Scope of this privacy policy

3. This privacy policy applies only to the actions of Dinat Engineering Ltd. and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
4. For purposes of the applicable Data Protection Laws, Dinat Engineering Ltd. is the "data controller". This means that Dinat Engineering Ltd. determines the purposes for which, and the manner in which, your Data is processed.

Data collected

5. We may collect the following Data, which includes personal Data, from you:

- a. name;
- b. contact Information such as email addresses and telephone numbers;

- d. IP address (automatically collected);
- e. web browser type and version (automatically collected);
- f. a list of URLs starting with a referring site, your activity on this Website, and the site you exit to (automatically collected);

How we collect Data

6. We collect Data in the following ways:

- a. data is given to us by you;
- b. data is received from other sources; and
- c. data is collected automatically.

Data that is given to us by you

7. Dinat Engineering Ltd. will collect your Data in a number of ways, for example:

- a. when you contact us through the Website, by telephone, post, e-mail or through any other means;
- b. when you use our services;

in each case, in accordance with this privacy policy.

Data that is received from third parties

8. Dinat Engineering Ltd. will receive Data about you from the following third parties, such as:

- a. Google Analytics;
- b. Facebook;
- c. Instagram;

Data that is collected automatically

9. To the extent that you access the Website, we will collect your Data automatically, for example:

- a. we automatically collect some information about your visit to the Website. This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.
- b. we will collect your Data automatically via cookies, in line with the cookie settings on your browser. For more information about cookies, and how we use them on the Website, see the section below, headed "Cookies".

Our use of Data

10. Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience when using our Website. Specifically, Data may be used by us for the following reasons:

Data retention

- 18. Even if we delete your Data, it may persist on backup or archival media for legal, tax or regulatory purposes.

Your rights

- 19. You have the following rights in relation to your Data:
 - a. **Right to access** - the right to request (i) copies of the information we hold about you at any time, or (ii) that we modify, update or delete such information. If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive." Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.
 - b. **Right to correct** - the right to have your Data rectified if it is inaccurate or incomplete.
